

## **Tanger Outlet Centers**

### **TERMS OF USE**

Last Updated: March 1, 2018

#### **GENERAL**

These Terms of Use (“Terms of Use” or “Agreement”) describe the terms and conditions under which users may access and use the Tanger Outlets website (“Website”) located at [www.tangeroutlet.com](http://www.tangeroutlet.com) or other internet based services such as the Tanger Outlets mobile App (herein referred to singularly and collectively as “Tanger Services”), which are owned and operated by Tanger Properties Limited Partnership d/b/a Tanger Outlets or Tanger Outlet Centers and its affiliates and subsidiaries (collectively “Tanger”). Each time User accesses and utilizes Tanger Services (whether merely browsing or otherwise), User is bound by these Terms of Use, so please read carefully and in its entirety. User is granted a limited, non-transferable, non-exclusive, license to access Tanger Services solely for personal, informational, and non-commercial purposes, which license may be revoked at any time. Tanger’s Privacy Policy is incorporated into and made part of these Terms of Use.

To the fullest extent permitted by applicable law, these Terms of Use constitute a binding legal agreement between User and Tanger and, by accessing and using the Tanger Services, User agrees to and accepts without limitation or qualifications these Term of Use and Privacy Policy. Tanger reserves the right to modify these Terms of Use and Privacy Policy in its sole discretion and without notification to users at any time by posting new or updated versions, as well as the right to provide additional notices of material changes.

Without limiting anything set out elsewhere in these Terms of Use, User's continued use of the Tanger Services is contingent upon User checking for any updates to the Terms of Use and Privacy Policy and User's agreement to be bound by any such revisions. User's continued right to access and ability to use the Tanger Services will terminate immediately, without any further action or notice by Tanger, if User fails to adhere to the Terms of Use or violates applicable law.

If Tanger discovers or is notified of communications or content that may violate these Terms of Use and/or any applicable law, rule or regulation, Tanger may determine in its sole discretion whether to remove or request the removal of the content, or to terminate the use of Tanger Services by the User who posted such content, but has no liability or responsibility to users for performance or nonperformance of such activities. Although Tanger is not obligated to screen communications or postings in advance and is not responsible for screening or monitoring the Tanger Services, or any element or component thereof, User acknowledges and agrees that Tanger has the right to monitor the Tanger Services in its sole discretion, and, notwithstanding anything to the contrary contained in the Privacy Policy, to disclose information as necessary or appropriate to satisfy any law, regulation or other governmental request, to operate the Tanger Services properly, or to protect itself or other users.

### **THIRD PARTY LINKS**

Tanger Services may include or provide links to third party sites. These links are only provided for the sake of convenience and do not imply, either directly or indirectly, that Tanger approves, authorizes, endorses or is affiliated with the linked site. User’s limited license to use and access Tanger Services grants no express or implied rights to or interest in these IP Rights or the IP Rights of any third party. The trademarks, logos, and service marks displayed on or contained within Tanger Services (“Marks”) are the intellectual property of Tanger or the appropriate third parties. User should include in the Notice:

- A physical or electronic signature of a person authorized to act on behalf of the owner of an exclusive right that is allegedly infringed.
- Identification of the copyrighted work or other intellectual property claimed to have been infringed.
- Identification of the material that is claimed to be infringing or to be the subject of infringing activity and that is to be removed or access to which is to be disabled, and information reasonably sufficient to permit the service provider to locate the material.
- Information reasonably sufficient to permit the service provider to contact the complaining party, such as an address, telephone number, and if available, an electronic mail address at which the complaining party may be contacted.
- A statement that the complaining party has a good faith belief that use of the material in the manner complained of is not authorized by the copyright owner, its agent, or the law.
- A statement that the information in the notification is accurate, and under penalty of perjury, that the complaining party is authorized to act on behalf of the owner of an exclusive right that is allegedly infringed.

If you are a copyright owner or an agent of a copyright owner and believe that any User-posted content on the Website infringes your copyrights, you may submit a Notice pursuant to the Digital Millennium Copyright Act ("**DMCA**") (17 U.S.C. § 512) by completing this [Notice of Copyright Infringement Form](#) or sending a written communication to our Copyright Agent with the following information:

- a. A physical or electronic signature of a person authorized to act on behalf of the owner of the copyright interest believed to be infringed;
- b. A description of the copyrighted work believed to be infringed;
- c. A description specifying the location on the Website of the material believed to be infringing
- d. Your email address, mailing address and/or telephone number;
- e. A statement that you have a good faith belief that use of the material in the manner complained of is not authorized by the copyright owner, its agent, or the law; and

- f. A statement, under penalty of perjury, that the information in the notice is accurate, and that you are authorized to act on behalf of the copyright owner.

## **JURISDICTION, CHOICE OF LAW, AND FORUM**

These Terms of Use and all Tanger Services are governed by the laws of the United States of America and the state of North Carolina without regard to conflict of law principles. Tanger makes no representation that Tanger Services, or content included therein, are appropriate or available for use in other locations. The exclusive jurisdiction for any claim, action, or dispute with Tanger relating to use of Tanger Services will be in the state and federal courts in North Carolina and the venue for adjudication and disposition of any claim, action, or dispute will be in the county of Guilford, North Carolina. User submits to personal jurisdiction of the courts located in Guilford County, North Carolina, for the purpose of litigating claims and disputes. To the fullest extent permitted by applicable law, no claim under these Terms of Use may be joined with or to any other claim, including but not limited to any legal proceeding involving other current or former users of Tanger Services, and no class action proceedings will be permitted.

## **ENTIRE AGREEMENT**

These Terms of Use constitute the entire agreement between Tanger and User with respect to Tanger Services and supersedes all prior or contemporaneous communications and proposals (whether written, electronic, or oral) between User and Tanger with respect to Tanger Services. The failure of Tanger to exercise or enforce any provision of this Agreement shall not operate or be construed as a continuing waiver or as a consent to a waiver of any subsequent breach hereof, or affect the ability to enforce such right at any time thereafter, unless in writing and signed by Tanger. The provisions of this Agreement shall be deemed severable such that the invalidity or unenforceability of any section of this Agreement, or any portion or provision thereof, shall not affect the validity or enforceability of the other portions or provisions. If for any reason a court finds any provision or term of this Agreement to be invalid or unenforceable then, to the fullest extent of the law, that provision shall be construed enforced to effect the intent of the parties, or in the alternative shall be stricken from the Agreement, and the remainder of the Agreement shall continue in full and given effect to the extent enforceable.
